PRODUCT DESCRIPTION: New Water® 90-Day Phos Remover is a powerful and reliable way to prevent phosphate build-up in pools. Phosphates constantly enters the pool water through source water, ground runoff, animals, and weather conditions. Preventing high phosphate levels eliminates poor water conditions. Package contains 3 pods, apply 1 pod per month.

DIRECTIONS FOR USE: Read entire label and use strictly in accordance with precautionary statements and directions.

Before applying New Water 90-Day Phos Remover, make sure all pool equipment is working properly, including pump, filter, skimmer and heater.

If recently used New Water 24-Hour Algaecide or New Water 90-Day Algaecide, wait at least 2 weeks before using New Water 90-Day Phos Remover.

1. Backwash or clean filter according to manufacturer's instructions.
2. Insert 1 New Water 90-Day Phos Remover pod directly to the skimmer basket. Run pump for 24 hours after adding product.
3. Remove empty pod and discard in trash or offer for recycling if available.
4. Use a new pod every month to keep phosphates from building up.

NOTE: If high levels of phosphates are present when you first use this product, your pool may become cloudy – particulates may drop to the bottom of the pool and should be vacuumed out. Continue to run your pump for 72 hours and backwash or clean the filter if the pressure increases 8-10 psi. Once pool water is clear, to maintain sparkling water, we recommend using New Water 90-Day Clarifier to help give your pool that extra sparkle.

STORAGE AND DISPOSAL: Storage: Keep this product in original container when not in use. Store in a cool, dry, well-ventilated area. Keep out of reach of children and pets.

Disposal: Non-refillable container. Do not reuse or refill this container. **If empty:** triple rinse and place in trash or offer for recycling, if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.

FIRST AID: IF SWALLOWED: Rinse mouth. Get medical help. **IF IN EYES:** Immediately rinse with water for several minutes. Remove contact lenses, if present and easy to do so. Continue rinsing. Get medical help. **IF ON SKIN OR CLOTHING:** Wash skin with plenty of
