Your Privacy Rights

Depending on your jurisdiction, you may have the right to opt out of the sale or sharing of your personal information, limit certain uses of sensitive personal information, object to certain processing, withdraw consent, or opt out of certain profiling or automated decision-making.

What this Request Covers

US State Law Rights

- Do Not Sell: Opt out of the sale of your personal information to third parties
- Do Not Share: Opt out of the sharing of your personal information for cross-context behavioral advertising or targeted advertising, where applicable
- Limit Use of Sensitive Personal Information: Request that we limit the use of sensitive personal information, where applicable

EEA/UK Rights

- Object to Processing: Object to certain processing of your personal data, including processing based on legitimate interests where applicable
- Withdraw Consent: Withdraw consent you previously provided for marketing or other consent-based processing
- Opt Out of Profiling or Automated Decision-Making: Request not to be subject to profiling or automated decision-making where such rights apply
