KTI has adopted this policy to protect and strengthen our well known FROG brand, to seek to mitigate potential risks related to product safety and quality, and to encourage our dealers to provide services to our customers commensurate with the reputation for quality and goodwill our customers associate with our products.

This policy is not a contract, nor an offer to form a contract. Instead this policy describes the terms under which KTI may, in its sole discretion and within its rights under the law, continue to supply to you our products, allow you to use our valuable intellectual property, including KTI's well-known trademarks, trade dress, advertising and product images (KTI Proprietary Rights), or to participate in any promotional, rebate or discount programs and/or carry special promotional products.

It is our policy that any advertisements of a KTI product listed on KING TECHNOLOGY, INC. MINIMUM ADVERTISING PRICE POLICY (MAP) Schedule A, must not be below the MAP price, net of any promotions, discounts, or rebates for that product listed in the schedule.

MAP pricing is as set forth on Schedule A except for any promotional prices communicated by KTI. This only applies to promotions communicated by KTI and any exceptions to the policy made by individual employees, sales agents, distributors, or other persons are not valid.
